Pursuant to the *Act* and Regulation, the facility, in respect of which this project is to be engaged in, is considered to be a Class 4 Wind Energy Generation Facility. If approved, this facility would have a total maximum name plate capacity of up to 10 MW. The project location is described in the map below.
